Product description.

A selfpolishing antifouling based on a biocidal, Drag Reducing Polymer (DRP) and pigmented with cuprousoxide. The hydrolyzing binder results in a constant renewal of the antifoulings surface. The product provides efficient control of fouling and can be recoated with itself after service life. The product is especially suitable for vessels sailing at medium speed.

Application data.

Guiding data Airless spray Pressure at nozzle: 120 -180 bar. Nozzle size: 0.41 - 0.58 mm.

Spray angle: 40 - 80 degrees. Volume of thinner: 0 - 3%.

Brush/Roller Suitable but airless spray is preferred. Multicoats may be needed to achieve

the specified dry film thickness.

Volume of thinner: 0 - 5%.

<u>Thinner/Cleaner</u> Transocean Special Thinner 6.01.

Conditions Humidity: below 90% RH.

Temperature of the paint before application: min: 10°C, max: 30°C.

Substrate temperature: min: 5°C, max: 30°C.

The temperature of the substrate should be at least 3°C above the dew point of the air. Air temperatures and relative humidity must be measured in the

vicinity of the substrate.

⁽¹⁾ The surface should be dry and free from fouling and other contaminants prior to overcoating. When in doubt, consult your nearest Transocean office.

Surface preparation.

Coated substrates The surface must be dry and free from fouling, salts and other contaminants.

Remove salts and dirt by fresh water washing and hard fouling by scraping. Corroded and/or damaged areas should be repaired first with an appropriate

primer system.

Recommended paint system.

Transocean Masterline Antifouling 2.82 can be applied on Transpoxy and Transvinyl priming systems. A typical system is shown below.

Transpoxy ARC 2.22 $2 \times 150 \mu$ dft. Transvinypox 2.06 $1 \times 75 \mu$ dft.

Transocean Masterline Antifouling 2.82 2 x 125 μ dft for 36 months protection.

Life times expectations are difficult to give, as it is dependent on many factors beyond our control such as vessel's speed and sailing pattern, seawater quality and temperature. Therefore the above stated antifouling specification should be used for guidance only. Consult your Transocean representative for more information.

Health and safety.

Observe the precautionary notices on the label of the container. A material safety data sheet is available upon request and national or local safety regulations should be followed. This product is intended for use by professional applicators.
